The *Journal of Applied Youth Studies* is a quarterly peer-reviewed journal. We welcome papers on all aspects of Asia-Pacific young people. The journal aims to present youth issues and research in a way that is accessible and reader-friendly, but which retains scholarly integrity. Papers are reviewed internally, then peer-reviewed, if they pass internal review.

All authors must read the *Journal of Applied Youth Studies licence agreement* (pages 2 – 4 of this document) and complete and return the signed agreement as part of the submission process.

(together referred to as **Author**; and *(delete the foregoing if not applicable)* **Employer**).

RECITALS

- A. The Publisher publishes the journal entitled “Journal of Applied Youth Studies” in print and online (**Journal**).
- B. The Author has submitted certain copyright material entitled _____ and an abstract and endnote relating to the same (**Article**), to the Publisher.
- C. The Author or their Employer owns the copyright in the Article.
- D. The owner of the copyright in the Article grants a licence to the Publisher on the terms set out in this agreement.

IT IS HEREBY AGREED Grant of Rights to Publisher

- 1. Where the Author is the owner of the Article, the Author grants to the Publisher an exclusive, worldwide, royalty-free, perpetual licence (including a right to sublicense) of all their rights comprised in the copyright in their contribution to the Article, including without limitation:
 - a. publishing the work in print and digital form and communicating it the public;
 - b. creating adaptations, summaries or extracts of the article or other derivative works based on the Article and to exercise all of the rights in such adaptations, summaries extracts and derivative works;
 - c. sub-licensing the Article in its published form to be communicated in full text online journal databases; and
 - d. collect copying fees from copyright collecting societies for *Journal of Applied Youth Studies*.
- 2. Where the Employer is the owner of copyright in the Article, the Employer grants to the Publisher a licence of rights in the Article on the same terms as clause 1.

Rights retained by Author/ Employer

3. In consideration of the licence granted to the Publisher by the Author or the Employer, the Publisher grants the Author and the Employer a non-exclusive, non-transferrable, royalty-free, worldwide right to:

a. upload or publish the Article onto an institutional repository, provided that:

- i. the Author is an employee or student of that institution; and
- ii. the Article is in its original form, not the form published in the Journal, and does not include the typeset or design of the Publisher;

b. reprint the Article in print collections of the Author's own writings;

c. reprint the Article in print format for inclusion in a thesis or dissertation that the Author writes;

d. present the Article at a meeting or conference presented by the Author; and

e. reproduce the Article for use in educational courses the Author is teaching;

and if the Author is employed by an academic institution, the Author is also granted the right to provide that institution with a non-exclusive, non-transferrable, royalty-free, worldwide right to reproduce the Article (and not the form published in the Journal) for teaching purposes.

4. Without limiting the proceeding terms of this agreement, the Author or the Employer may seek the permission of the Publisher to publish or upload the Article in the form published in the Journal and if such permission is granted, the Author must ensure that such publication includes:

a. an acknowledgement that permission was received to archive the published version; and

b. a notice stating the origin of the material, including the volume, edition and date of the Journal from which the paper has been sourced; and

c. an acknowledgement of the Publisher's copyright in the version published in the Journal.

Warranty of Author and Employer

5. The Author, and Employer to the best of its knowledge, jointly and severally warrant to the Publisher:

a. the Article is an original literary work and has not been published elsewhere in a substantially similar form or with substantially similar content;

b. the Author or the Employer is the unencumbered owner of the all of the copyright subsisting in the Article;

c. the Article does not contain obscene, indecent, objectionable, defamatory, libellous, misleading or deceptive material or likely to mislead or deceive;

d. when published, the Article will not violate any third party intellectual property rights (including moral rights); and e. together they have power to enter into and comply with the terms of this agreement.

Other

6. The Publisher may assign this agreement or any right arising out of this agreement to a third party, provided that third party agrees to fulfil the Publisher's obligations contained in this agreement.

7. The laws of the State of Tasmania will apply to this agreement. Each party submits to the jurisdiction of the State of Tasmania.

8. The agreement comes into effect on the date of this agreement and shall remain in force for the lifetime of the copyright in the Article.
